Lok Sabha Provisionally Admitted Question 18992 - regarding Indian fishermen detained in foreign countries,

(a) whether the Government has maintained any data regarding details of Indian fishermen detained in various foreign countries;

Currently, there are five Indian fishermen detained in Seychelles.

(b) if so, the details thereof and the reasons for the detention countrywise including Seychelles, Indonesia, Maldives during the last three years;

On 6th March 2022, the Seychelles Coast Guard intercepted three Indian Fishing Vessels, namely, INFANT JESUS, DONO and ST SNABAKA ARULAPPER comprising of 35 Indian fishermen on the suspicion of illegal fishing in the Seychelles Waters with a huge illegal catch of dolphins, sharks and other species. They were produced before the Supreme Court of Seychelles on 7th March 2022 and remanded under custody for 14 days upto 22nd March 2022. On 11th March 2022, 26 more Indian fishermen onboard two fishing vessels, namely, VADIMATA and VIDHYA were apprehended by the Seychelles Coast Guard on suspicion of illegal fishing in the Seychelles Waters.

- 2. All 61 fishermen were produced in the Supreme Court of Seychelles on 22nd March 2022, out of which 56 fishermen were released due to mission's efforts. These 56 fishermen were repatriated to India by the Mission onboard Indian Air Force IL76 aircraft on the same day. The remaining five captains/skippers of the fishing boats have been charged with offence of fishing without foreign vessel license under the Foreign Fisheries Act of the Government of Seychelles and have been remanded to custody till 5th April 2022 by the order of the chief Justice of Supreme Court of Seychelles.
 - (c) the details of precautionary steps taken by the Government to prevent the detention of Indian fishermen abroad; and

(d) the steps taken by the Government to ensure release of the fishermen imprisoned in foreign countries and provide assistance to them for their rehabilitation?

56 out of 61 fishermen apprehended in Seychelles were released by the Supreme Court of Seychelles on 22nd March 2022 and they were repatriated to India by Indian Air Force IL76 aircraft.
